Sub-Chapter 38 minutes for the Executive and Membership meetings are recorded to help the Recording Secretary to produce minutes for each meeting. Pursuant to the previous direction of the membership these recordings shall be disposed of as soon as reasonably possible after the Sub-Chapter 38 membership has approved the minutes. The minutes are not or intended to be an actual verbatim record of the proceedings but are summarized notes of the agenda items, motions maker of the motion, votes and lengthy discussions.

Motion by Brother John Hubert, properly supported by Brother Douglas Wadlin, to suspend the regular order of business at 1:02 pm to allow two State Representatives and Mark Mueller as guest speakers to address the membership. The motion carried.

Representative Darrin Camillari, 23rd District, which includes Brownstown Township and other parts of the downriver area, is in his 2nd term as a State Representative. He was a teacher prior to being elected to office in the 2016 general election and currently serves as the Democratic Whip in the State House and also serves on the Education Committee. The Governor is prioritizing education and roads in her proposed budget. We do not currently on a proposed budget beginning October 1st because there is a stalemate between the Governor and the Republicans that control both chambers of the legislature. The small amount that Republicans are proposing in Education budget does not begin to touch the difference in per pupil spending between Michigan and states with higher overall results in student education. The last promise of more road funding was to be matched with \$600 million from the State General Fund appropriation which never happened so the promise of more roads funding never was carried out. Until new money is invested in roads in the future, our roads will continue to decline.

Representative Laurie Pohutsky is a newly elected State Representative for District #19, which is primarily Livonia. She is a scientist with a Bachelor's Degree in Microbiology from Michigan State. She

is working on environmental projects such as the PFA's in Michigan. The law the State adopted that limits Michigan law's to Federal laws is severely handicapping environmental efforts in Michigan. PFA's in the water in Michigan is a severe problem but Federal law is very liberal on this issue and the law that requires Michigan to adopt the Federal levels of PFA's is harming the residents of Michigan. She has introduced a law on micro-plastics in Michigan. They are looking at adopting a more accurate way to measure things that cause toxic algae blooms. Laws have been introduced to deal with some of the problems with water, but they have not gotten a hearing as yet.

Brother Macdonald introduced the next speaker, Mark Mueller, Sygma Planning, who is here to explain further the changes that are taking place and answer questions He discussed the deferred compensation changes and Plan 4 changes for the County. Candy Myers, Prudential Insurance, made a presentation. She is the Prudential representative who will handle the Wayne County portfolio.

READING OF MINUTES

Brother Macdonald made the motion, properly supported by Brother Pendracki, to waive the reading and approve the minutes of the Executive Board meeting of July 9, 2019, as corrected, leaving the record open to the end of the meeting for corrections, additions, or deletions and adopt as corrected. The motion carried.

Brother Macdonald made the motion, properly supported by Brother Pendracki, to waive the reading and approve the minutes of the Membership meeting of July 9, 2019, as corrected, leaving the record open to the end of the meeting for corrections, additions, or deletions and adopt as corrected. The motion carried.

REPORT OF OFFICERS

PRESIDENT:

A letter was sent to many of our retirees from Management and Budget, Benefits Division, requesting verification of eligibility for continuation of the retiree healthcare stipend. It states that failure to return the form could result in the suspension of benefits. This letter was in addition to the letter sent out by TASC to verify eligibility for the monthly retiree healthcare stipend. I contacted the County to get clarification of their letter and was told that the letter was intended for retirees that were under age 65 and not eligible for Medicare or retirees that were over age 65 and eligible for Medicare but had dependents that were under age 65 and would still be eligible for the County provided healthcare supplement that is based on your income They were not sure why people not affected were sent the letter and requested that we clarify this matter so that retirees not affected did not return the letter.

Brother Macdonald and I attended a Ways and Means Budget Hearing which included the Retirement System. The state of the pension fund is steadily improving. It has risen from a low of 44% funded to 62% funded with the Airport at 72% funded. The Accrued Liability is at a 10-year low and the number of employees retiring has been going down over the recent past which means that more retirees are dying than retiring each year. The county has been making its Annual Required Contributions (ARC) to the pensions system as well as additional payments which have helped accelerate the funding status of the System. The current ARC is 52.2 million dollars and the county has stated that it will be making its required contribution.

We discussed the possibility of an increase in the stipend for retirees receiving Medicare with some of the Commissioners and they said that there were funds in the proposed budget to address this issue. We requested a copy of the proposed plan so that we could update our membership and they said they would have a copy forwarded to us. We have not heard from the County Executive's Office on whether they support this particular line item.

Brother Sockolosky read his summary report of the July 15, 2019, meeting with Sub-Chapter 38 representatives and the Wayne County Administration regarding the HRA issues. This County

gave its claims regarding the current HRA arrangement; how it sees the HRA plan and it maintains that the Sub-Chapter will not have a role in administering the HRA. It reiterated that Wayne County owns the HRA's; the dollars in the funds are the property of Wayne County and it cannot be allocated to the retirees. When the retiree dies; the balance in the fund reverts back to Wayne County. Wayne County believes the settlement agreement gives it wide latitude to administer the agreement.

Motion by Brother Pendracki, properly supported by Sister Bauman to accept the President's report. The motion carried.

VICE-PRESIDENT: None SECRETARY TREASURER

Financial Report

Brother Macdonald reported that the Sub-Chapter has \$134,166.21 in cash and investments as of July 31, 2019. There are 1,325 current members with 190 participating in the PEOPLE Plan and (69) members were lost this calendar year.

Motion by Brother Pendracki, properly supported by Sister O'Leary-MacGillis, to accept the Treasurer report as presented. The motion carried.

Secretary-Treasurer Report, Comments and Announcements Two Pending Arbitration Cases

There were three (3) grievances filed by AFSCME and its Local Unions relating to pension issues of which two (2) survived various court hearings and were remanded for arbitration. They

- 1. Elimination of 13th Check: The grievance dealt with the changes Evans and the County Commission to eliminate the funding of the 13th check, taking that money (\$32+ million) away from retirees and using the thirty-two + million dollars, in the "13th check account, as a required County contribution to the pension system.
- 2. Medical Insurance for Disability Retirees: For (30) years, the County had a practice which was supported by the various CBAs and the pension ordinance which provided that people who retired on a duty or non-duty disability pension were entitled to medical insurance as part of their retirement. In 2010, CEO Ficano eliminated this program and the Union filed an unfair labor practice and prevailed. The County then filed a challenge in the Michigan Court of Appeals and the Court of Appeals ruled that the matter must be resolved by way of grievance arbitration.

The Sub-Chapter has been assisting legal counsel in preparation for arbitration. Legal counsel anticipates that an evidentiary hearing on either matter will be unnecessary with all of the factual data stipulated by both sides. Submission of stipulations was to be by August 12, 2019. Should the parties not agree on the proposed stipulations, the arbitrator may rule on acceptability or order evidentiary hearings. Sub-Chapter 38 remains committed to assisting legal counsel during the arbitration processes.

WAYNE COUNTY LAWSUIT TO SEAT EVAN'S BOARD

Wayne County CEO Evans filed a lawsuit against the Wayne County Employees' Retirement System Commissioners (WCERS) demanding the ability to seat his handpicked WCERS Board by expanding the Board to ten (10) members while eliminating one (1) active employee Commissioner and one (1) retired member Commissioner. Wayne County Circuit Judge Leslie Kim Smith issued an opinion on July 31, 2017 denying Evans the ability to seat his WCERS Board. Wayne County filed an appeal with the Michigan Court of Appeals (Case No. 339714) and an appellate court decision, dated May 9, 2019, confirmed the ruling of Judge Smith. Wayne County has filed a motion to reconsider with the Michigan Court of Appeals and a hearing on that motion has not been scheduled.

PRESCRIPTION CO-PAY SETTLEMENT

Payments by Wayne County of both Medicare eligible and Non-Medicare stipends appear to be consistent with the settlement agreement. The Sub-Chapter continues to pursue a grievance on the issue of the many problems with the Health Reimbursement Accounts at TASC (formerly Genesis). As a partial response the Sub-Chapter received a list from Wayne County of 996 HRA accounts at TASC with balances of more than \$3,000.00 totaling over \$3.5 million. It is evident that the only resolution to those grievances is a mutually acceptable Health Reimbursement Account (HRA) Plan and that every Medicare eligible class member know their rights and responsibilities under the plan. The Sub-Chapter is seeking mutually agreed upon HRA plan or that at least a summary plan document provided to every current and future Medicare eligible retiree. A meeting with Wayne County was held on July 15, 2019 with limited progress toward these goals. The primary problem is communication with affected retirees. Wayne County and the Sub-Chapter are both working on developing a communication plan.

During a meeting with the Chairman of the Wayne County Committee on Ways and Means it appears that the Sub-Chapter may get some relief for Medicare eligible stipend recipients below the poverty level. A recent discussion with other commissioners reinforces that impression. With the Commission budget deliberations beginning soon we will get a better idea of what to expect.

Brother Parked addressed the membership and announced he is resigning from his position of Trustee effective this date (8/13/2019) due to his upcoming move to New Mexico. Motion by Brother Macdonald, properly supported by Sister O'Leary-MacGillis, to accept the resignation of Charles Parker from the position of Sub-Chapter 38 Trustee (term ending October 2021) effective August 13, 2019). The motion carried.
